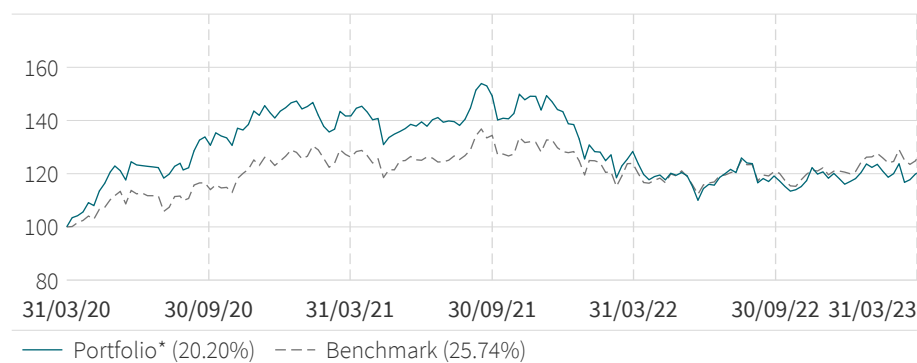

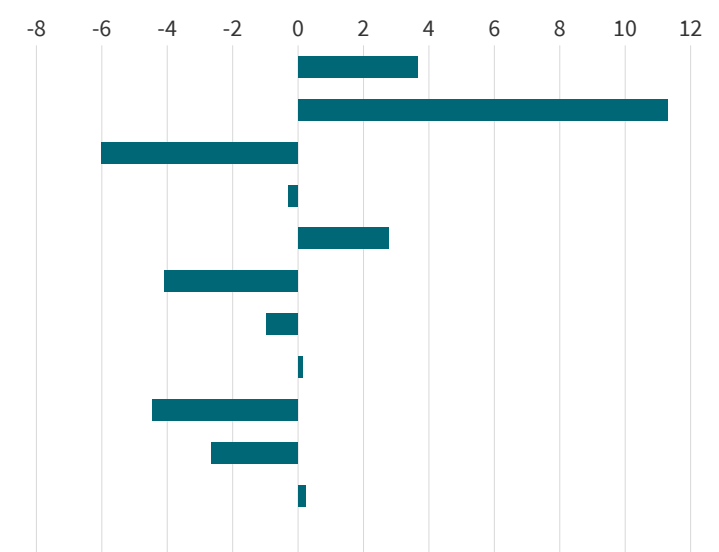

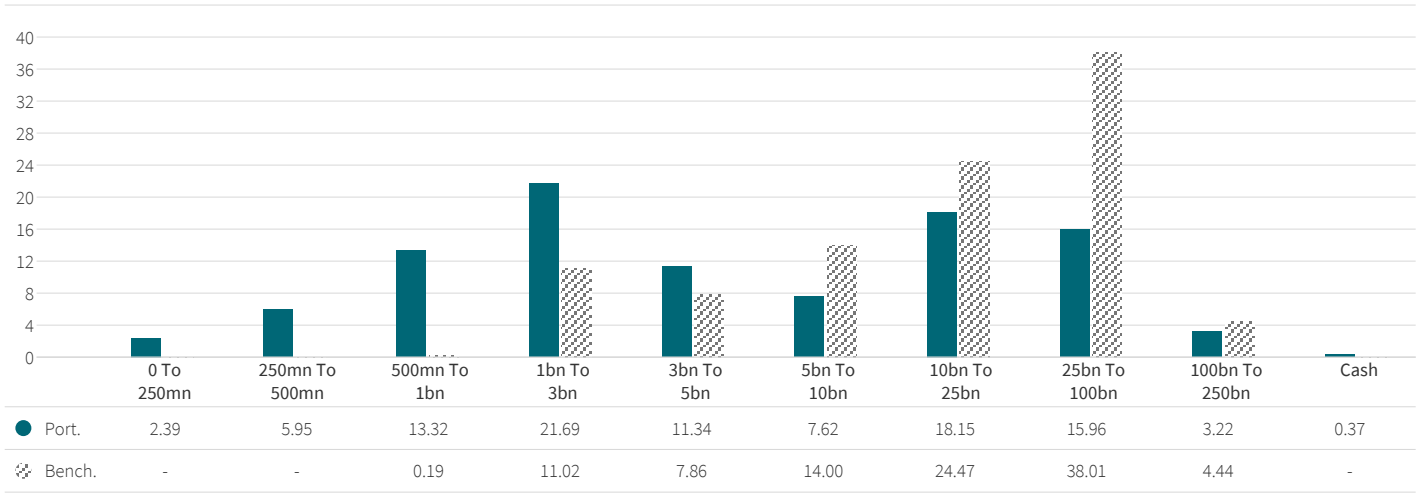

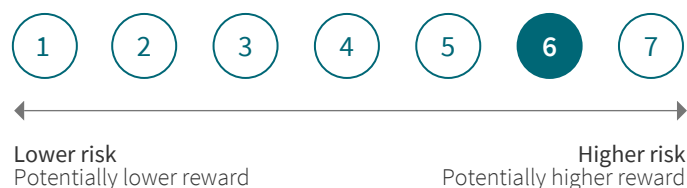
Fund Objectives
