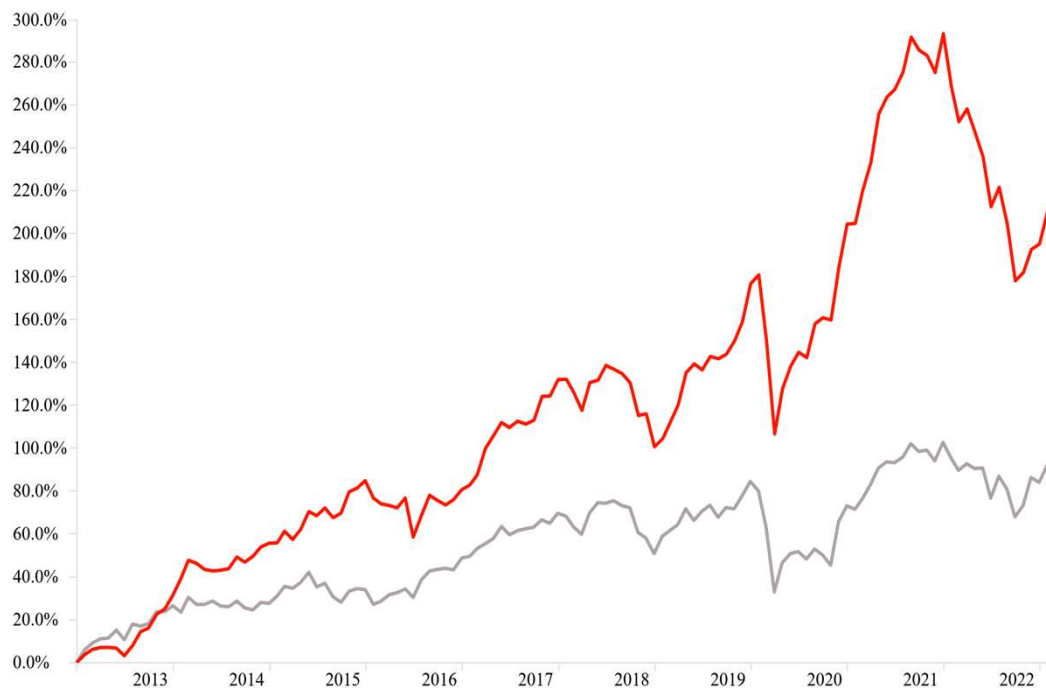

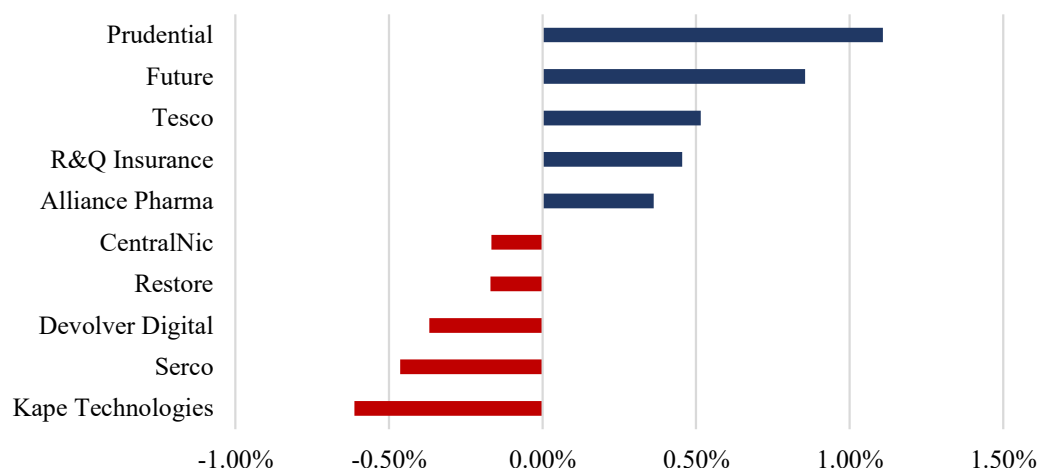
Cumulative Performance

Top 5 Contributors and Detractors

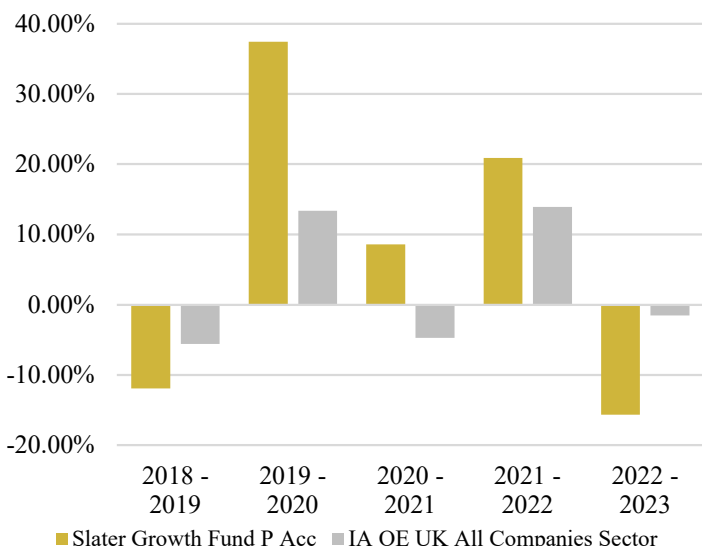
