Equity fund focusing on Chinese A-shares



Investment Objective

The fund concentrates on the stocks of companies that are incorporated in China and that are listed as A-shares on the stock exchanges of Shanghai or Shenzhen. The fund engages specifically with high carbon emitters in order to promote climate consciousness. A maximum of 20 % of the fund's assets may be invested in other stocks of companies that are incorporated in China or that generate a predominant portion of their profits there. The fund's investment objective is to attain capital growth over the long term.

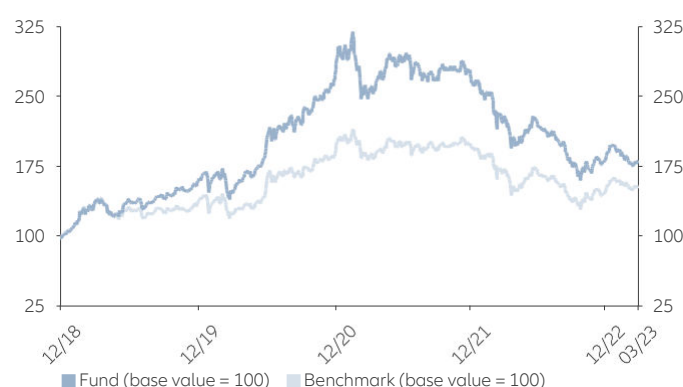

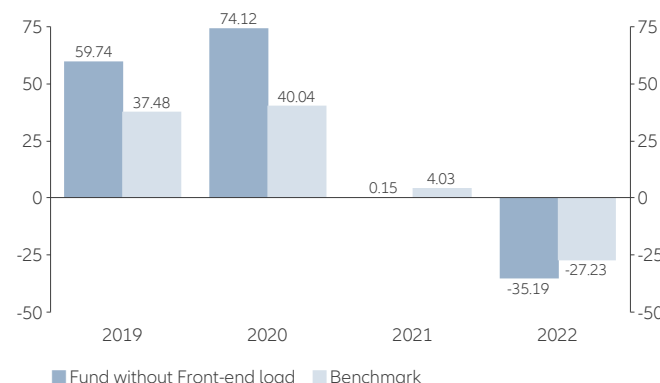

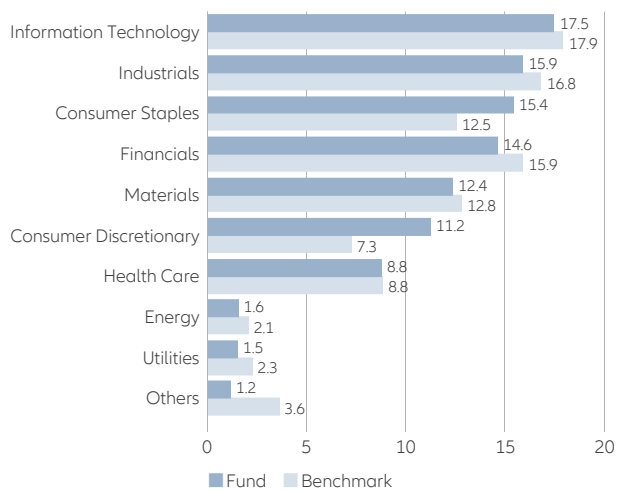
