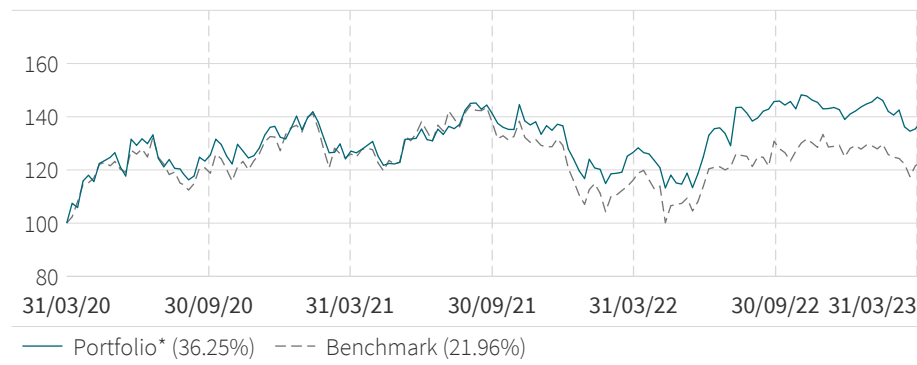

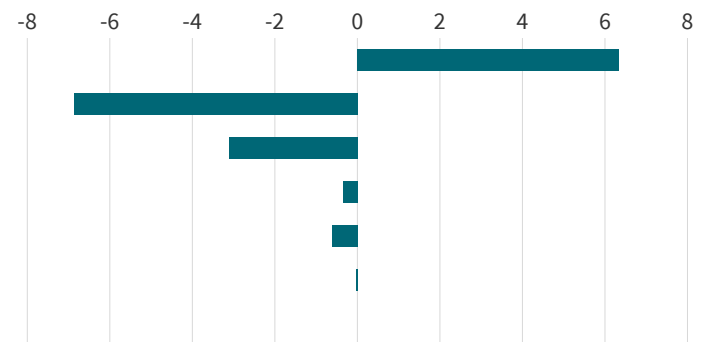

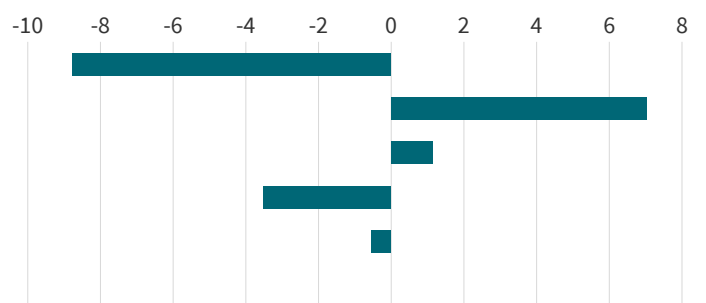
Active Exposure by Sector (%)



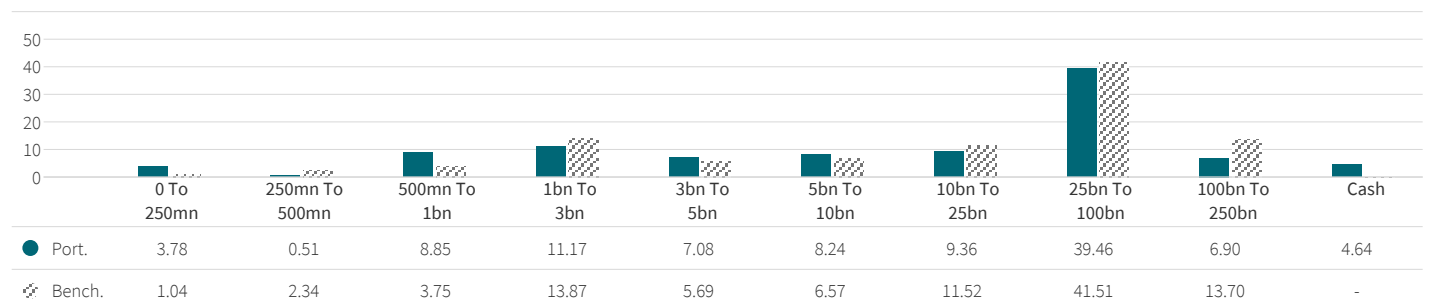

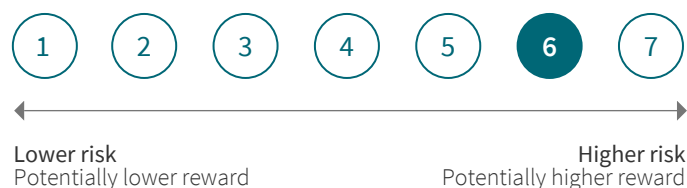
Fund Objectives
